Insurance at the basic extent is concluded with the territorial extent Domestic and international, incl. former Yugoslavia and USSR (European part)

Out of the framework of the insurance in the basic extent, the insurance is also concluded at the extent of the following clauses:

Clause V 30 Insurance of liability for damage, which occurred to the transported clothes

The insurance at the extent of V30 clause is concluded with sublimit of compensation in CZK 10 000 000,-
The insurance at the extent of V30 clause is concluded with the territorial extent Czech Republic and Europe

Clause V 32 Insurance of liability for damage, which occurred to the transported used or damaged motor vehicles

The insurance at the extent of V32 clause is concluded with sublimit of compensation in CZK 2 000 000,-
The insurance at the extent of V32 clause is concluded with the territorial extent Czech Republic and Europe

Clause V 33 Insurance for a case of theft of the transported load

The insurance at the extent of V33 clause is concluded with sublimit of compensation in CZK 10 000 000,-
The insurance at the extent of V33 clause is concluded with the territorial extent Czech Republic and Europe, incl. former Yugoslavia

This certificate serves only as a confirmation of insurance. It comes into force only in connection with the Insurance Contract and the above mentioned Insurance Terms and Conditions VPPOS 2005 and DPPD 09.
